Sir / Madam,

You are hereby informed that the Competent Authority, NDMC has approved distribution of dry ration i.e. food grains (Aata, Rice), Pulses, Oil and Fat to the students of Primary and Upper Primary classes studying in NDMC / NDMC aided and Navyug Schools for the months October 2021 to December 2021 and January 2022 to March 2022 in compliance of GNCT Delhi's letter / order no. DE 23 (763) /MDM/ 2020-21/ 1289-1339 dated 21.02.2022. Details of the dry ration to be distributed are as follows:-

The following directions are also issued to NGO / Service Providers for strict compliance by the Govt. of NCT of Delhi with immediate effect :-

- 1. NGOs/Service Providers has already lifted food grains (wheat / rice) from FCI godowns @ 100 gms. & 150 gms. per child per day for Primary and Upper Primary children respectively for 3<sup>rd</sup> Qtr. Of 2021-2022 also for 4<sup>th</sup> qtr. is being picked up from FCI Godown. They are further directed to prepare separate food grain packets (rice or wheat packets on alternative basis i.e. each child shall get both the food grains proportionately) for each school child (primary and upper primary classes). The schedule of providing Food grains along with pulses, oil etc. shall be finalized by NGOs/Service Providers in consultation with School Principals / MDM Incharges as per school enrollment of MDM beneficiaries and the same shall be distributed to parents from school premises only with the help of CCHs.
- 2. Transportation cost shall be provided to service providers as per usual practice and prescribed rates for lifting of food grains from FCI godowns to respective centralized kitchens / godowns.
- 3. Honorarium to Cook cum Helpers shall be provided to Service Providers as per prescribed rates for utilizing their services in preparation of packets of dry ration, distribution of packets in schools etc.
- 4. Cooking cost / conversion cost shall be provided to Service Providers as per prescribed rates for providing pulses, oil with 'A' grade / Ag-mark etc. (equivalent to cooking cost) at the quantity prescribed by the Ministry.
- 5. The NGOs / Service Providers shall submit their bills to the concerned District DDE along with proper receipt from concerned School Principal / HOS as per proforma enclosed.
- 6. No extra payment on account of packing / transportation / administrative expenses (kitchen rent, electricity, water etc.) will be made except the cooking cost. The NGOs / Service Providers shall be paid at the rate of Rs.4.97 (Rs.4.09 for dry ration + 0.88 paise for packing cost/other administrative expenses etc.) for Primary and @ Rs.7.45 (Rs.6.14 for dry ration + 1.31 for packing cost / other administrative expenses etc.) for Upper Primary for per student per day only for supply of above dry ration as per guidelines of Ministry of Education, GOI.

7. A compliance report regarding delivery of dry ration kits to all eligible students through HOS/Principals/Vice Principals by all NGOs/Service Providers shall be submitted within 15 days.
